JOB SUMMARY: Under supervision performs a variety of cleaning and disinfection duties within the entire production plant site; operates cleaning machines; keeps the site free of spills, debris, removes rubbish and waste to demarcated bins and skips; and performs a variety of related duties as assigned.

DUTIES AND RESPONSIBILITIES:

(Include, but not limited to)

- Maintain workplace safety rules, follow established procedures and ensure the set plant parameters are always
- Perform assigned treatment plant walkdowns, inspect, monitor operational and equipment settings in area of responsibly
- Removing any debris from the site to the allocated bins and skips.
- Cleaning of spills and build-up of production material using spades and wheelbarrows or water hoses. Includes flushing screens and plates.
- Various grounds maintenance duties such as weed eating, weeding, levelling of ground, digging of holes etc.
- Decanting and manual handling of plant chemicals under supervision.
- Report emergency conditions and breakdown to line.
- Operation of submersible pumps under supervision during cleaning operations.
- Store all tools, equipment and materials in the allocated storerooms.
- Maintain good condition of plant, tools and equipment. Report damaged or broken tools and equipment on the same day to the supervisor allocated.
- Assist with maintaining a log of activities and system logs, as required by recording all events on the hourly shift logbook
- Assist with stock taking, sampling and daily flow totalizer reading activities.
- Assist maintenance staff with cleaning of equipment, moving of equipment and basic plant operations.
- Assist with the offloading of chemicals and checking chemical levels
- Assist operational staff with daily operational activities
- Conduct risk assessments daily before commencing with any work for all associated tasks.
- Comply with required site cleaning schedules. Maintain a cleaning register, signing off critical task daily.
- Operates and maintains cleaning machines such as high-pressure cleaners, weed-eaters, light electrical equipment etc.;
- Perform related duties as required.
